## JAMESTOWN 4-H CENTER

A youth facility located on 16 acres along the James River near the historical Jamestown settlement in Virginia. The facility has served as a summer camp for 4-H'ers in eastern Virginia since 1946. ## We have plans in place to provide a safe camp community.

All campers must provide proof of a negative COVID test within 7 days prior to the beginning of camp OR provide a 14-day symptom screening for the camper and family members. By utilizing the symptom screening, campers must restrict their close contact with those outside the family for the duration of the 14-day period.

Expect a "touchless" check in procedure upon your arrival. Staff will greet you at your vehicle and whisk your camper away to begin their camp experience. To reduce the number of people at camp at one time, check-in procedures and times will be staggered.

We are following all of the recommended guidelines for health and safety including best practices for cleaning and sanitizing our facilities. We expect all campers and staff to wear a mask.

Our Dining Halls will operate at reduced capacity and outdoor dining will be an option. Campers will stay with their group for all meals served.

Cabin and lodge layouts will be modified to address social distancing and group size. Campers do not need to wear masks while sleeping.

Our staff team are continually using resources to adapt operations including: The American Camp Association, Virginia Department of Health, Association for Camp Nurses and the Center for Disease Control and Prevention.
